**Data Controller ID**

Your personal data will be processed by **M.A.C. İPLİK FABRIC TEKS in the capacity of data controller. SAN. A.Ş. A.S.** ("Company" or "M.A.C.") may be processed by us within the scope of the Law on the Protection of Personal Data No. 6698 ("Law") as stated below. Detailed information about the purposes for which your personal data is processed by our Company [www.mactextile.com.tr](http://www.mactextile.com.tr), **M.A.C.** It is included in the Personal Data Protection and Processing Policy.

**Personal Data and Processing Purposes**

In order to control the physical space for security reasons, camera recordings are taken inside, outside the building and in its annexes (at the points where there is a camera sign), and your visual and audio records and physical space security data are provided by us in accordance with the Law and the basic principles stipulated in the Law, ensuring the security of movable goods and resources, creating and tracking visitor records, information to authorized persons, institutions and organizations. **It is obtained and processed for the purposes of giving.**

**Method and Legal Reason for Collecting Personal Data**

Your personal data will be collected electronically and your collected personal data will be collected in accordance with Article 5 of the Law. Provided that it is mandatory for the data controller to fulfill its legal obligation specified in the article, provided that it does not harm its fundamental rights and freedoms, it can be processed based on the legal reason that data processing is mandatory for the legitimate interests of the data controller, and it can be transferred to authorized persons, institutions and organizations based on the legal reason that it is mandatory due to the establishment, exercise and protection of a right.

**As a personal data owner, your rights within the scope of Article 11 of the Law are as follows.**

- To learn whether your personal data is processed or not,
- If your personal data has been processed, requesting information about it,
- To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom your personal data is transferred at home or abroad,
- Requesting correction of your personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to third parties to whom your personal data has been transferred,
- Although it has been processed in accordance with the Law and other relevant provisions of the law, to request the deletion or destruction of personal data in the event that the reasons requiring its processing disappear, and to request the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- Objecting to this in the event that a result arises against you by analyzing the processed data exclusively through automated systems,
- Requesting compensation of the damage in case you suffer damage due to unlawful processing of your personal data.

Your request will be concluded free of charge as soon as possible and within thirty days at the latest. If an additional cost is required to carry
