

## WEBSITE PRIVACY POLICY

### Data Controller ID

("M.A.C." or "Company") <https://www.mactextile.com.tr> protecting the privacy of visitors to the website ("Data Subject") is one of the leading principles of our Company. With the Website Privacy Policy ("Policy"); Explanations are made about the processing of personal data of Data Owners and the enforcement of the Website Privacy Policy.

### Processing of Personal Data of Data Owners

During your visit to our website, your personal data is not collected within the scope of the Law on the Protection of Personal Data No. 6698 ("Law") and therefore is not transferred to any institution or person. Apart from this, you can find detailed information about the processing of your personal data [in the](#) Personal Data Protection and Processing Policy.

First of all, during the filling out of the contact form on our website, your identity and contact information, including name, surname, e-mail address, number, for the purpose of carrying out communication activities, in **accordance with the Law and the basic principles stipulated in the Law**, provided that it does not harm the fundamental rights and freedoms of the person concerned, based on the legal reason that data processing is mandatory for the legitimate interests of the data controller,

Your personal data, which is detailed in the Employee Candidate Clarification Text during the filling out of the Job Application Form, is collected and processed for the purpose of Conducting the Application Processes of Employee Candidates and based on the legal reason for "establishment or performance of the contract" and can be transferred to authorized public institutions if it has a legal basis.

In addition, some mandatory cookies are collected during your visit to our website. Cookies are small data storage files that are saved on your computer, mobile phones, tablets or other mobile devices that you access by websites.

### Which Cookies Are Used For What Purposes?

In order to increase the quality of use of our users using the website, to increase the benefit of use by facilitating the use of the site, and to improve our website and prevent the possibility of security vulnerabilities, the data of the parts visited/accessed by the users/visitors when they enter the website are processed.

- **To perform the basic functions necessary for the operation of the Site.** For example, logged-in members do not need to re-enter passwords when visiting different pages on the Site.
- **To analyze the Site and to improve the performance of the Site.** For example, the integration of different servers on which the Site runs, determining the number of visitors to the Site and adjusting performance accordingly, or making it easier for visitors to find what they are looking for.

Pursuant to Articles 5 and 8 of the KVK Law and/or in the presence of exceptions in the relevant legislation, your personal data may be processed in line with your consent when required in accordance with the legislation, otherwise for the above purposes without your consent.

### **Cookies Used on Our Site**

Below you can find the different types of cookies we use on our site. Both first-party cookies (placed by the site you visit) and third-party cookies (placed by servers other than the site you visit) are used on our site.

- **Mandatory Cookies**

The use of certain cookies is mandatory for the proper functioning of our site. For example, authentication cookies, which are activated when you log in to our site, ensure that your active session continues when you switch from one page to another on our site.

- **Functionality and Preference Cookies**

These cookies remember your preferences and choices on the site and personalize the services offered on our site for you. For example, it allows us to remember your language selection on our site or the font size you have chosen when reading a text.

### **Rights of Data Owners**

We inform you that as a personal data owner, you have the following rights in accordance with Article 11 of the Law:

- To learn whether your personal data is processed or not,
- If your personal data has been processed, requesting information about it,
- To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom your personal data is transferred at home or abroad,
- Requesting correction of your personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to third parties to whom your personal data has been transferred,
- Although it has been processed in accordance with the Law and other relevant provisions of the law, to request the deletion or destruction of personal data in the event that the reasons requiring its processing disappear, and to request the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- Objecting to this in the event that a result arises against you by analyzing the processed data exclusively through automated systems,
- Requesting compensation of the damage in case you suffer damage due to unlawful processing of your personal data.

You can submit your applications regarding your rights listed above to our Company by filling out the Data Owner Application Form, which you can access at <https://www.mactextile.com.tr> Depending on the nature of your request, your applications will be concluded free of charge as soon as possible and within thirty days at the latest; however, if the transaction requires an additional cost, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.

### **Enforcement of Website Privacy Policy**

The Website Privacy Policy enters into force on the date it is published. In case of renewal of all or certain articles of the Policy, the effective date of the Policy will be updated.
