Personal Data and Processing Purposes

Pursuant to the Law No. 5651 on the Regulation of Publications Made on the Internet and Combating Crimes Committed Through These Publications, your data regarding identity, transaction security, risk security, including your computer name and log records, are carried out by us in accordance with the Law and the basic principles stipulated in the Law, and ensuring the security of data controller operations, informing authorized public institutions and organizations. **will** be obtained, processed and transferred for its purposes.

Method and Legal Reason for Collecting Personal Data

- Although it has been processed in accordance with the Law and other relevant provisions of
 the law, to request the deletion or destruction of personal data in the event that the reasons
 requiring its processing disappear, and to request the notification of the transaction made within
 this scope to the third parties to whom your personal data has been transferred,
- Objecting to this in the event that a result arises against you by analyzing the processed data exclusively through automated systems,
- Requesting compensation of the damage in case you suffer damage due to unlawful processing of your personal data.

Your request will be concluded free of charge as soon as possible and within thirty days at the latest. If an additional cost is required to carry out the transaction subject to your request, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.
